There were several members of the public who offered comments on the proposed temporary regulation. Each person stated opposition to the proposal to combine the C 19 and C 20 classifications. Several spoke in favor of adding an additional subclassification to the C 19 classification for the installation of slab granite and marble.

Ms. Grein thanked the participants for taking the time to express their comments and adjourned the workshop at 10:30 a.m.

Ms. Grein stated that several members of the public offered comments at the workshop held earlier in opposition to the regulation as it is written. Ms. Grein summarized the comments and indicated that the participants at the workshop were in favor of keeping both the C 19 (Installing terrazzo and marble) and the C 20 (Tiling) classifications. Many spoke in favor of adding an additional subclassification to the C 19 classification for the installation of slab granite and tile. Ms. Grein further stated that based upon the comments received at the workshop, the regulation will be brought back to the Board for revision, she also indicated there may be a need for the Board to institute a new examination requirement for applicants for a C 19 classification license. The Board will review the proposal at an upcoming Board meeting.

Ms. Grein thanked the participants for taking the time to express their comments and adjourned the hearing at 11:00 a.m.
