tended and focused on topics of lien laws, employment laws, and overall construction laws of relevance to the conversation.







Lynn joins Contractors Board

Lynn was hired by the Clark County Department of Building and Fire Prevention in February 1981 to oversee matters of department administration, legal aspects of building codes, finance and management, building codes, building performance standards, and construction issues. His decorated career includes affiliations spanning local to international organizations, including past president of the Board of Directors of the International Code Council (ICC), member of the Board of Directors of the International Accreditation Service, member of the Board of Managers for the International Evaluation Services, Nevada State Hazard Mitigation Planning Steering Committee, the Nevada Bureau of Mines & Geology Advisory Committee, and was appointed to the National Earthquake Hazards Reduction Program Federal Advisory Committee on Earthquake Hazards Reduction by the National Institute of Standards & Technology.

Recent accomplishments of Lynn include being recognized

Board nets felony fraud conviction

A two-year investigation by the Nevada State Contractors Board's Fraud Unit and federal authorities has resulted in indictments against two men associated with Recreational Development Company.

On July 27, a federal grand jury indicted the North Las Vegas general contractor's president, Jeffrey Whittle, and general manager, Brian Vanderburgh, on one count of conspiracy and four counts of wire fraud.

NSCB opened an investigation after receiving a tip in August 2014 alleging Recreational Development falsified invoices on a Veterans Administration clinic constructed in 2010-11. The extensive investigation uncovered evidence allegedly showing eight separate invoices were falsely submitted at a total value of \$281,000, and that illegal payments were being made to the developer's on-site representative and RDC.

After issuing 38 subpoenas, identifying and reviewing 19 bank accounts and acquiring more than 12,000 related documents, NSCB forwarded the case to the U.S. Attorney's Office who brought in the FBI to pursue potential federal violations.

Whittle has entered a guilty plea to the Conspiracy charge and is awaiting sentencing on November 21, 2016.

Gardner named to education panel

Governor Brian Sandoval announced the appointment of Robert Gardner to the Commission on Construction Education. His appointment will run from July 1, 2016 thru Jun. 30, 2019.

Gardner has been involved in the construction industry since 1977. Upon graduation from college in 1986, he worked as a project manager for Harper Mechanical in Orlando, Fla., completing an indepth training program, which covered all areas of mechanical contracting. In 1989, he accepted a project manager's position with Gardner Engineering, Inc. and immediately took charge of the Ely Maximum Security Prison project; a remote project, valued at over 8 million dollars, spanning four years of construction.

Gardner has since progressed to overall construction manager in charge of all field personnel, field operations and the estimating department,

while continuing to manage large construction projects. He also is ultimately responsible for project profitability by establishing accurate project cost estimates and then maintaining construction efficiency and cost control. Overall, Gardner's education, experience and training make him uniquely suited for the role of construction manager.

"The Nevada State Con-

tractors Board is pleased to welcome Mr. Gardner to the Commission on Construction Education," said NSCB Executive Officer Margi A. Grein. "We look forward to the contributions of Mr. Gardner as he aids the Commission in furthering the education and development of Nevada's construction workforce."

Gardner replaces Tom Pellett, whose term expired on June 30. Sandoval reappointed the other board members: Chair Shawn Danoski. Ed Horan, Dale Lowery, David McElwain and Brian Plaster. Kent Lay was also selected by the Contractors Board in 2016 to serve on the Commission.

The commissioners are responsible for distributing and overseeing grant funds to approved organizations, including high schools, with the goal of teaching students and young professionals construction

Solar firm's victims compensated

Nevada The State Contractors Board held a Residential Recovery Fund subcommittee meeting August 4, where it ordered \$400,000 in financial recourse be made to 133 homeowners damaged by former licensed contractor Summerlin Energy Las Vegas, LLC.

"To be able to provide homeowners financial recourse after they have been taken advantage of by a licensed underscores contractor importance of the Board's mission to protect the public," said NSCB Executive Officer Margi A. Grein. "We empathize greatly with the circumstances each homeowner in this case experienced and want stress the importance of hiring licensed Nevada contractors for any home repair or remodel work to ensure the public receives the full protections

the Board has to offer, should something go wrong during the course of a project."

Pursuant to Nevada Revised Statute 624.510, the Residential Recovery Fund may afford eligible homeowners of single family residences up to \$35,000 in financial recourse; however, claims may not exceed \$400,000 per contractor. Claims from the 133 homeowners totaled approximately \$1.44 million, therefore every homeowner received a prorated amount equal to 38.3 percent of the value of their validated claim values.

The Board began receiving complaints from homeowners against Summerlin Energy in November 2015, with a significant number of complaints filed – by vendors as well as homeowners – by the end of January 2016. On February 3, 2016, the Board

summarily suspended the licenses of Summerlin Energy, forbidding the company from entering into any new contracts for work while the Board's investigation continued.

On March 31, a disciplinary hearing was held where Judge Philip M. Pro ordered the revocation of Summerlin Energy's licenses. Pro made the ruling after hearing testimony from Board investigators, homeowners, and suppliers alleging Summerlin Energy took money without providing work or material, failed to pay its vendors, which led to vendors placing liens on properties after homeowners had paid Summerlin Energy in full.

Pro sustained 46 of the 48 Causes of Action against Summerlin Energy, which were affiliated with nine complaints – seven from homeowners and two from yendors.

in 2009 by the United States Congress for his contributions in building safety and awarded the Senatorial Commendation for his commitment to building safety, energy conservation, and emergency response in 2010.

In 2014, he received the Community Achievement Award by the Asian American Group, the Government Person of the Year Award by the International Association of Plumbing & Mechanical Officials, and the 2014 Western States Seismic Policy Council Lifetime Achievement Award.

The International Code Council recognized Lynn with its highest award, the prestigious Bobby J. Fowler Award, in 2015 for his career of leadership in the building safety industry to achieve a safer built environment.

skills and career opportunities in the construction industry. Grant recipients include community colleges, technical high schools and construction career seminar providers.

The Commission on Construction Education is funded through voluntary contributions and fines the State Contractors Board levies in disciplinary actions against licensed contractors.

The 2001 session of the Nevada State Legislature established the commission to encourage programs that meet the mission of improving quality and integrity in the construction industry to attract and retain an educated and skilled work force.

More than 60 contractors attended the Nevada State Contractors Board's Contractor Training Day in Las Vegas on Sept. 13. Three dozen more participated in a similar event in Reno on Aug. 23. The events are part of the Board's efforts to serve the state's construction industry through advocacy and education.

Training day offers legal tips

Nearly 100 of Nevada's licensed contractors received an intense primer on contract and employment law at seminars hosted by the Nevada State Contractors Board in Reno and Las Vegas.

The Board's annual "Contractor Training Day," on August 23 at the Reno chapter of the Associated General Contractors and September 13 at the Clark County Building Department featured lectures and interactive discussions of liens, labor law, construction law, and other topics of interest to Ne-

vada contractors.

Attorneys Mark Ricciardi, Paul Georgeson and Cary Domina donated their time to enlighten construction company employees at the free half-day sessions. Georgeson in Reno and Domina in Las Vegas explained that the lien process can be complicated without proper legal counsel. Their sessions were designed to help guide contractors through the ins and outs of legally filing a lien, including notifications, deadlines and due diligence.

Ricciardi delivered his talk

on labor law at both the Reno and Las Vegas sessions. He focused on ensuring workers are classified and compensated correctly. He discussed state and federal regulations regarding discrimination and unlawful termination and ways construction firms can protect themselves from lawsuits.

The program continues the Contractors Board's educational seminars that brings together experts in various fields to help contractors better conduct their businesses. Previous years have

offered instruction on marketing and public relations, the state's building codes, the Americans with Disabilities Act, and efforts to control unlicensed contracting.

This year's speakers made use of multimedia and made their visual aids available to all in attendance. The 90-minute time limit per session left many attendees desiring more, and the Board plans to offer similar programs at least annually moving forward.

"The Board is pleased to offer seminars to help Nevada's contractors rebound from the tough economy and position themselves to prosper during the recovery," said NSCB Executive Officer Margi Grein. "We had a great turnout at both venues, which encourages us to plan similar events in the coming months."

Seminar topics, gleaned from extensive contractor surveys, were designed to provide a spectrum of information construction managers cannot easily obtain elsewhere in a one-stop location, Grein said. She said this information forms the basis contractors need to build their businesses in the new competitive atmosphere in which property values increase and investment capital becomes available.

"The training sessions give contractors an opportunity to step away from the day-to-day concerns of scheduling, payroll, etc. to consider some of the 'big picture' issues that can make the difference in a profitable future," Grein said.



Hosting the seminars also fits seamlessly into the Board's mission and industry outreach goals.

The Board is committed to

protect the integrity and professionalism of the construction industry in Nevada. It is responsible for promoting quality construction by Nevada licensed contractors through a regulatory system designed to protect the health, welfare, and safety of the public. By educating the building community on ways they can remain compliant with state laws, protect and increase their businesses, the Board improves the quality and quantity of Nevada's licensed contractors.

Based on feedback received from previous sessions, future Board training seminars may include sessions on business plans, OSHA regulations lead and asbestos abatement, customer service and more.

Board revokes, fines licenses

The Nevada State Contractors Board took action against several licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its July, August and September hearings in Reno and Henderson.

Home Perfect Inc., license number 67360A, (painting) based out of Sparks, Nev., was found in violation for Failure to pursue a project with reasonable diligence, failure to establish financial responsibility, failure to keep in force a bond or cash deposit, failure to include the license number or monetary limit on a bid or contract, failure to comply with a notice to correct, failure to provide a homeowner information regarding the Board's Residential Recovery Fund, contracting beyond the scope of the license and substandard workmanship. The license was revoked. Licensee was fined \$3,200, assessed investigative costs and ordered to pay restitution.

Designing with Nature Inc., license number 48686 () was found guilty of contracting beyond the scope of the license, failure to comply with the terms of a contract or warranty, substandard workmanship, failure to comply with a notice to correct and failure to establish financial responsibility. The license was suspended. Licensee was fined \$6,500, assessed investigative costs and ordered to provide a financial statement supporting the license limit.

Rod Aaron Koprek, dba Rod Koprek Roofing, license number 50820 (roofing and siding), based out of Las Vegas, Nev., was found in violation for substandard workmanship, failure to comply with the state's building laws, failure to cooperate in an investigation, failure to include Residential Recovery Fund information in a bid or contract, disregard of the state's building laws and failure to comply with an order from the board. The license was revoked. Fines and

investigative costs were not assessed due to the respondent's filing for bankruptcy.

Alternative Drilling Company, LLC, license number 73955 (drill wells, install pumps, pressure tan), based out of Spring Creek, NV had its license placed on probation and may not take on any new work pending review of charges and submission of a current financial statement.

Complete Bath Remodeling of Las Vegas, LLC, dba 5 Day Kitchens of Las Vegas, license number 78859 (finish carpentry) based out of Las Vegas, NV, was found in violation for failure to establish financial responsibility. Licensee was fined \$500, assessed investigative costs, and ordered to pay restitution. The license was voluntarily surrendered.

Esprit Construction, license number 47286 (residential and small commercial), based out of Salt Lake City, Utah, was found in violation for bidding in excess of the monetary limit placed on the license, entering into a contract with an unlicensed person, conspiring with an unlicensed person to perform an unauthorized act, acting as an agent, aiding and abetting an unlicensed person, and failure to establish financial responsibility. Licensee was fined \$2,200 and assessed investigative costs.

Bruce Douglas Spangrud, dba Galaxy Outdoor, license number 73383 (carpentry), based out of Las Vegas, NV, was found in violation for failure to establish financial responsibility, contracting beyond the scope of the license, and bidding in excess of the monetary limit placed on the license. Licensee was fined \$4,500 and assessed investigative costs. A current financial statement that supports the monetary limit

Be a "card-carrying" licensed contractor

The Nevada State Contractors Board continuously reminds property owners to check contractors' pocket identification cards before agreeing to proposals, signing contracts or allowing anyone to perform work on their homes or businesses.

As these outreach efforts continue, NSCB also encourages all licensed contractors to carry the pocket cards while on the job and especially in situations where they think they might be soliciting business.

The hard plastic license pocket cards recently were redesigned to include NSCB's logo and the state seal in addition to the license number, business name, classification(s), and license expiration date. One card is issued upon issuance and renewal of the license. NSCB allows con-

must be submitted to the Board within 60 days of the hearing date or the license will be suspended.

Russell Filand Builders, Inc., license number 68291 (general building), based out of Peoria, Ariz., was found in violation for failure to establish financial responsibility, failure to cooperate in an investigation, failure to produce requested information or records, committing a fraudulent or deceitful act and failure to keep in force a bond or cash deposit. The license was revoked. Licensee was fined \$5,000 and assessed investigative costs.

Total Energy Solutions, Inc., dba T.E.S., license numbers 76205 (carpentry) and 78635 (plastic tile and wallboard), based out of Henderson, Nev., was found in violation for failure to comply with a written citation, failure to keep in force a bond or cast deposit and failure to establish financial responsibility. Both licenses were revoked. Licensee was fined \$3,000 and assessed investigative costs.

Nevada Delta Mechanical Inc., license number 72999 (plumbing) and Delta Mechanical, Inc., license numbers 53330 (plumbing) and 75345 (air conditioning), based out of Mesa, Ariz., had the limits reduced to \$50,000 as a result of findings from the May 4 disciplinary hearing.



Nevada Contractor's Checklist

The following information is provided to help Nevada Contractors work within the law. For full text of laws that affect contracting in Nevada, see The State of Nevada "State Contractors Board Handbook," Chapter 624 of the Nevada Revised Statutes and Chapter 624 of the Nevada Administration Code. Contact the Nevada State Contractors Board for a copy.

Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Keep your bond current. NRS 624.270
Check to ensure that licenses or persons with whom you contract are valid and active. NAC 624.650
Be sure name of business under which contractor is contracting is the same as the li- cense number. NRS 624.305
Be sure the amount of the bid or contract is within the monetary limit of the contractor. NRS 624.3015(2)
Be sure that the contract is within the scope of work/license classification. NRS 6243015(3)
Know what you are contracting for, verify terms of the contract, and comply with terms of the contract. NRS 624.3013(1)
If it is not in your written contract, it doesn't exist. Make sure all change orders are in writ- ing and signed by all parties. NRS 624.3013(1)
Include Residential Recovery Fund Disclosure on all residential contracts. NRS 624.520
Provide customers with required Notice to Owner Disclosure, NRS 624.600(1)(2) and (3) as described in NAC 624.693 & NAC 624.6932
Make sure your license number is on all business advertisements, including vehicles, business cards, letterhead, signage, directories, newspapers, website, etc. NRS 624.720
Always make sure license number and monetary limit is on all contracts or bids. NAC 624.640(5)
Your license number should be approximately 1 1/2 inches on your motor vehicle. NRS 624.288
If your address or other pertinent information about the business changes, notify Contractors Board in writing within 30 days. NAC 624.640(3)
