CONTRACTORS BOARD TAKES DISCIPLINARY ACTION AGAINST TEN CONTRACTORS

(*Henderson*, *NV*) - At its meeting on November 29, 2004, the Nevada State Contractors Board adjudicated cases against ten (10) licensed contractors.

Unique Tile & Marble Inc., license number 55593 (Tiling) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to obtain required lien release; contracting in excess of established license limit; failure to provide required Residential Recovery Fund disclosures; failure to cooperate in the investigation of a complaint; failure to include license number and monetary limit on a contract or proposal; failure to establish financial responsibility; and failure to comply with a written request from the Board. The Board revoked the license of Unique Tile & Marble.

Rockwood Development Corp., license numbers 50217 (Residential and Small Commercial) and 50218 (Carpentry) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for a fraudulent or deceitful act in the capacity of a contractor; and failure to establish financial responsibility. The licensee was placed on probation, fined \$3,000, assessed the cost of investigation, ordered to provide a financial statement and ordered to submit to a Business Review.*

Darby Joe Neagle dba Darby Neagle Enterprises, license number 45040 (Residential and Small Commercial), Darby Neagle Enterprises, license number 46603 (General Engineering) and Western Pacific Contractors, license number 53199 (General Engineering) based out of Las Vegas, Nevada were found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility; failure to comply with a written request from the Board; and failure to include license number and monetary limit on a contract or proposal. The licensee was fined \$1,600, assessed the cost of investigation and ordered to provide a financial statement.

Taggart Construction, license number 47458 (Residential and Small Commercial) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; abandonment of a construction project; failure to prosecute a construction project; failure to establish financial responsibility; failure to comply with a written request from the Board; failure to provide required Residential Recovery Fund disclosures; combining with an unlicensed person to perform an unauthorized act; illegal transfer of a license; failure to cooperate in the investigation of a complaint; and willful disregard of building laws. The Board revoked the license of Taggart Construction.

Luckier Roofing, license number 50952 (Roofing) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for substandard workmanship; failure to comply with a notice to correct; failure to cooperate in the investigation of a complaint; failure to establish financial responsibility; failure to comply with a written request from the Board; contracting beyond the scope of the license; failure to pay an administrative fine; failure to include license number and monetary limit on a contract or proposal; and failure to provide Residential Recovery Fund disclosures. The Board revoked the license of Luckier Roofing.

Parks and Son Plumbing, license number 46886 (Plumbing and Heating) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to establish financial responsibility; failure to comply with a written request from the Board; a fraudulent or deceitful act committed in the capacity of a contractor; contracting with a suspended license; failure to cooperate in the investigation of a complaint; failure to keep in force a bond or cash deposit; and, failure to include the license number and monetary limit on a contract or proposal. The Board revoked the license of Parks and Son Plumbing.

JA Vay & Sons Inc., license numbers 52716 (General Engineering) and 17183 (General Building) based out of North Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for failure to pay for materials or services; failure to establish financial responsibility; failure to comply with a written request from the Board; and failure to include license number and monetary limit on a contract or proposal. The Board revoked the license of J A Vay & Sons Inc.

Pro-Scape, license number 39066 (Landscape Contracting) based out of Las Vegas, Nevada was found in violation of Nevada Revised Statute 624 for contracting beyond the scope of the license; failure to comply with a written citation; failure to pay an administrative fine; failure to establish financial responsibility; failure to comply with a written request from the Board; failure to obtain a required lien release; failure to provide required Residential Recovery Fund disclosures; failure to include license number and monetary limit on a contract or proposal; and failure to comply with the regulations of the Board governing pool construction contracts. The Board revoked the license of Pro-Scape.

*The Business Review Program is one in which contractor's business practices and regulatory compliance is examined by NSCB investigative staff. The program is a part of NSCB's proactive investigative efforts.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.
