Ms. Grein explained the purpose of the workshop is to receive public comment on proposed amendments to Chapter 624 of the Nevada Administrative Code to clarify the requirements for contractors to be eligible to qualify for a certificate of eligibility. The Board originally adopted the changes as a temporary regulation. This workshop is to complete the process of adopting the amendment as a permanent regulation. The Legislative Counsel Bureau File No. is R014-07.

Ms. Grein indicated that the notice of the workshop and hearing had been posted in compliance with NRS 233B at the Las Vegas City Hall, the Sawyer State Building, Clark County Library, Washoe County Courthouse, Washoe County Library, Reno City Hall and the offices of the State Contractors Board in Reno and Henderson.

Since there were no members of the public present to offer comment on the proposed amendment, Ms. Grein closed the workshop. Ms. Grein stated a hearing on the proposed amendment will be held Friday, September 7, 2007 at 10 a.m.
