FINANCIAL RESPONSIBILITY HEARING: Continued from July 6, 2011
FACILITIEQ BUSINESS INTERIORS INC, LICENSE NO. 68051

Licensee was present.

Hearing Officer Drake found Respondent guilty of one (1) violation of NRS 624.3013(3) failing to establish financial responsibility. License shall be placed on probation until December 2011 and must provide a financial statement and bank verification form no later than the 15th of each month through December, 2011, and submit to a business review. Respondent must pay an administrative fine of \$250.00 and investigative costs of \$929.69 within thirty (30) days or license will automatically be suspended.

3. FINANCIAL RESPONSIBILITY HEARING: Continued from July 6, 2011
TAYLOR REFRIGERATION, LICENSE NO. 57909

Licensee was present.

Hearing Officer Drake found Respondent guilty of (1) violation of NRS 624.3013(3) failing to establish financial responsibility and one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. The monetary license limit is reduced to \$25,000.00 with the bond to remain at \$10,000.00. Respondent must pay an administrative fine of \$500.00 and investigative costs of \$1,041.34 within thirty (30) days.

GERALD GLENN GARRARD, LICENSE NO. 73398

6. FINANCIAL RESPONSIBILITY HEARING
D & K LANDSCAPE INC, LICENSE NO. 43694

Licensee was present.

Hearing Officer Alexander found Respondent guilty of one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. The monetary license limit is reduced to \$3,000,000.00. Licensee must provide a current financial statement within six (6) months that supports the license limit or license will automatically be suspended. Respondent must pay an administrative fine of \$250.00 and investigative costs of \$463.78 within thirty (30) days or license will automatically be suspended. The First Cause of Action is dismissed.

7. FINANCIAL RESPONSIBILITY HEARING
VLADCO INC, LICENSE NO. 59278

Licensee was present.

Hearing Officer Alexander found Respondent guilty of (1) violation of NRS 624.3013(3) failing to establish financial responsibility and one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. The license is suspended for sixty (60) days until a current financial statement or personal indemnification agreement is provided to staff to support the license limit. Respondent must pay an administrative fine of \$500.00 and investigative costs of \$528.78 within thirty (30) days.

8.FINANCIAL RESPONSIBILITY HEARING
PINNACLE RESTORATION LLC, LICENSE NO. 74915

This matter was continued.

9.FINANCIAL RESPONSIBILITY HEARING
EXPLORE GENERAL INC, LICENSE NO. 74716

Licensee was not present.

Hearing Officer Alexander found Respondent guilty of one (1) violation of NRS 624.3013(3) failing to establish financial responsibility and one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. License number 74716 is revoked. Respondent must pay an administrative fine of \$500.00 and investigative costs of \$470.91.

10. FINANCIAL RESPONSIBILITY HEARING
UNITED PROTECTED LLC, LICENSE NO. 74742

Licensee was not present.

Hearing Officer Alexander found Respondent guilty of one (1) violation of NRS 624.3013(3) failing to establish financial responsibility and one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. License number 74742 is revoked. Respondent must pay an administrative fine of \$500.00 and investigative costs of \$483.41.

11. FINANCIAL RESPONSIBILITY HEARING
VERTICAL CONSTRUCTION CONCEPTS LLC, LICENSE NO. 74757

Licensee was present.

Hearing Officer Alexander found Respondent guilty of one (1) violation of NRS 624.3013(3) failing to establish financial responsibility and one (1) violation of NRS 624.302(6) failing to comply with a written request by the Board. License is suspended until the licensee provides a current financial statement, bank verification form, bond, and proof of good standing with Nevada Secretary of State. Licensee is not to perform any work in the State of Nevada while suspended. Respondent must pay an administrative fine of \$500.00 and investigative costs of \$473.40 within ninety (90) days or license will automatically be revoked.
