1. FINANCIAL RESPONSIBILITY HEARING – CONTINUED FROM SEPTEMBER 5, 2012

Hearing Officer Drake found the Respondent R T Construction LLC, license number 75866 guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply with written request of the Board. Respondent must pay a fine of \$750.00 and investigative fees in the amount of \$950.34. License number 75866 is revoked.

NORTHERN NEVADA EXCAVATING, LICENSE NO. 57312**

Hearing Officer Quinn found Respondent Northern Nevada Excavating, license number 57312 in default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. Licensee was found guilty of violating NRS 624.3011(1)(b)(2) by willfully or deliberately disregarding and violating the safety or labor laws of the State; NRS 624.3013(4) by failing to keep in force the bond or cash deposit pursuant to NRS 624.270 for the full period required by the Board; NRS 624.3013(3) by failing to establish financial responsibility. License number 57312 was revoked. Respondent shall pay an administrative fine in the amount of \$1,250.00 and reimburse the Board for investigative costs of \$1,768.00.
