ADMINISTRATIVE LAW JUDGE: BRUCE ROBB

1. DISCIPLINARY HEARING-DEFAULT HEARING:
DESERT MOUNTAIN TILE, LICENSE NO. 31978

Licensee was not present nor represented by counsel.

Administrative Law Judge Bruce Robb found the Respondent Desert Mountain Tile, license number 31978 in default and adopted the recommendations of prosecuting counsel. Licensee was found guilty of violating NRS 624.3012(2) failure to pay for materials and services and NRS 624.3013(3) failure to establish financial responsibility. License number 31978 was revoked. The Respondent was ordered to pay a fine of \$1,000.00 for the First Cause of Action and \$500.00 for the Second Cause of Action for a total fine of \$1,500.00. Respondent shall pay full restitution to Earth Stone Gallery and reimburse the Board for investigative of \$2,165.00 prior to re-licensure.

RICHARD JOSEPH CONSTRUCTION INC, LICENSE NO. 75001

Administrative Law Judge Bruce Robb found the Respondent Richard Joseph & Company, license numbers 54489, 60517 and 68945 guilty of violating NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license and NRS 624.3013(3) failure to establish financial responsibility. License numbers 54489, 60517 and 68945 are revoked. No fines or fees were imposed. Richard Joseph Construction Inc, license number 75001 was ordered to provide a current financial statement to the Board within ten (10) days of March 6, 2013.

3. NEW APPLICATION DENIAL HEARING:
CRESTWOOD CONSTRUCTION INC.

Licensee was present.

Administrative Law Judge Bruce Robb approved the license with a \$1,000,000.00 monetary license limit and a \$30,000.00 bond.

4. FINANCIAL RESPONSIBILITY HEARING:
F T S I LLC, LICENSE NO. 76416

Licensee was not present, but was represented by L. Evensen, Esq.

Administrative Law Judge Bruce Robb found the Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility. License number 76416 is suspended. Respondent must submit a request to surrender the license within sixty (60) days, pay a fine of \$250.00 and investigative fees in the amount of \$495.91 within thirty (30) days or license number 76416 will automatically be revoked.

5. FINANCIAL RESPONSIBILITY HEARING:
A F I INC, LICENSE NO. 76492

Licensee was not present.

Administrative Law Judge Bruce Robb suspended license number 76492. License shall remain suspended for sixty (60) days or until licensee has reinstated the bond, provided the required financial information and paid the investigative fees of \$483.41. After it provides the required information, it may submit an application to place the license on inactive status. Licensee must pay costs within thirty (30) days of March 6, 2013 or the license will be revoked.

6. FINANCIAL RESPONSIBILITY HEARING:
ADVANCED INTEGRATION SOLUTIONS LLC, LICENSE NO. 76507

Licensee was not present.

Administrative Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply with written request of the Board. Respondent must pay a fine of \$1,000.00 and investigative fees in the amount of \$473.41. License number 76507 is revoked.

**7. FINANCIAL RESPONSIBILITY HEARING:
COIT SERVICES OF RENO LLC, LICENSE NO. 76684**

Licensee was present.

Administrative Law Judge Robb lowered the license monetary limit to \$120,000.00 and a \$10,000.00 bond. Respondent shall pay investigative fees in the amount of \$489.66 within thirty (30) days or the license will be automatically suspended.

**8. FINANCIAL RESPONSIBILITY HEARING:
MEDIATEL GROUP LLC, LICENSE NO. 76522**

Licensee was not present.

Administrative Law Judge Robb found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply with written request of the Board. Respondent must pay a fine of \$1,000.00 and investigative fees in the amount of \$467.53. License number 76522 is revoked.

**9. NEW APPLICATION DENIAL HEARING:
SACRAMENTO REFRIGERATION INC.**

Licensee was present.

Administrative Law Judge Bruce Robb approved the license with a \$10,000.00 monetary license limit and a \$2,000.00 bond. Respondent shall provide to staff the Order for Dismissal" dismissing case number M-08-0992 signed on February 25, 2013, by Judicial Officer Julia L. Scrogin of Yuba County Superior Court.

**10. NEW APPLICATION DENIAL HEARING:
GRAND CANYON CONSTRUCTION INC**

Licensee was present.

Administrative Law Judge Bruce Robb approved the license with a \$2,800,000.00 monetary license limit and a \$30,000.00 bond.

**11. NEW APPLICATION DENIAL HEARING:
CHARLES THOMAS FLINT DBA, T F ELECTRIC**

Licensee was present.

Administrative Law Judge Bruce Robb approved the license with a \$5,000.00 monetary license limit and a \$5,000.00 bond. Respondent shall provide the proper financial statement to staff within thirty (30) days from March 6, 2013.
