Hearing Officer Leggett found Respondent Cheney Construction, license number 40475 guilty of violating NRS 624.3013(5), as set forth in NRS 624.700(3)(a) failure to comply with the Board's Notice to Correct and NRS 624.3013(3) failure to establish financial responsibility. License number 40475 is suspended. The First Cause of Action was dismissed. No administrative fines were imposed on the Second and Third Causes of Action. Investigative fees in the amount of \$2,307.00 are to be paid within ninety (90) days of January 8, 2014 or license number 40475 will automatically be revoked. Respondent shall reimburse Franklin Tucker \$30,500.00 within ninety (90) days of January 8, 2014 or license number 40475 will automatically be revoked. If the investigative fees and reimbursement to Mr. Tucker are paid within ninety (90) days license number 40475 shall be placed on inactive status per the Respondent's request.
