Hearing Officer Leggett found Respondent Sione Seleti Mokofisi dba, Mokofisi Construction, license number 69852 guilty of violating NRS 624.3016(1) fraudulent or deceitful act; NRS 624.3015(1) acting in the capacity of a contractor beyond the scope of the license; NRS 624.3013(5), as set forth in NRS 624.520(1) failure to provide Residential Recovery Fund Notice to owner; NRS 624.3013(5), as set forth in NAC 624.640(5) each licensee shall include in all bids he submits or contracts he enters into for construction work within this State, the number of his license and any monetary limit placed upon his license; NRS 624.302(5) failure to respond to a written request from the Board or its designee to cooperate in the investigation of a complaint and NRS 624.3013(3) failure to establish financial responsibility. License number 69855 is suspended. Fines were assessed in the amount of \$2,000.00 for the First Cause of Action, \$2,000.00 for the Second Cause of Action, \$250.00 for the Third Cause of Action, \$1000.00 for the

Fourth Cause of Action, \$250.00 for the Fifth Cause of Action and \$2,000.00 for the Sixth Cause of Action for a total of \$7,500.00 and investigative fees in the amount of \$2,446.00 are to be paid within sixty (60) days of January 7, 2015 or license number 69852 will automatically be revoked. Respondent shall provide a current financial statement that supports the monetary license limit prepared by a CPA within sixty (60) days of January 7, 2015 or license number 69852 will automatically be revoked.
