ADJUDICATING HEARING OFFICER: JAN B. LEGGETT

1. DISCIPLINARY HEARING-DEFAULT HEARING:
D & S ELECTRIC INC., LICENSE NO. 58543

Licensee was not present.

Hearing Officer Leggett found Respondent D & S Electric Inc, license number 58543 in default and adopted the Findings of Fact and Conclusions of Law as set forth in the Administrative complaint. Licensee was found guilty of violating NRS 624.305(1) and (2) Unlawful use, assignment or transfer of license; revocation of license. No license may be used for any purpose by any person other than the person to whom such license is issued, and no license may be assigned, transferred or otherwise disposed of to permit the unauthorized use thereof. The license of any person who violates any provision of this section shall be automatically cancelled and revoked; NRS 624.720(3) unlawful advertising; (3) all advertising by a licensed contractor must include the name of the contractor's company and the number of the contractor's license; NRS 624.3013(5) pursuant to NAC 624.640(3) if any change occurs in a licensee's address or personnel which affects the accuracy of the statements in the application upon which his or her license is based, the licensee shall report the change in writing to the Board within 30 days after the change occurs

and NRS 624.3013(3) failure to establish financial responsibility. License number 58543 was revoked. Respondent shall pay a fine of \$1,000.00 for the First Cause of Action, \$250.00 for the Second Cause of Action, \$250.00 for the Third Cause of Action and \$500.00 for the Fourth Cause of Action for a total fine in the amount of \$2,000.00 and reimburse the Board for investigative costs of \$2,410.00.

2. DISCIPLINARY HEARING:
MARATON CONSTRUCTION LLC, LICENSE NO. 78359

Licensee was present with William Melquist, Legal Assistant for Alfonso Garcia, Esq.

Hearing Officer Leggett suspended license number 78359 and continued this matter to the November 4, 2015 hearing.

3. FINANCIAL RESPONSIBILITY HEARING:
LEELAS BUBBLES WALK IN BATHTUBS LLC, LICENSE NO. 78999

Licensee was not present.

Hearing Officer Leggett found Respondent guilty of violating NRS 624.3013(3) failure to establish financial responsibility and NRS 624.302(5) failure to comply. License number 78999 is revoked. Respondent must pay a fine in the amount of \$750.00 and investigative fees in the amount of \$468.56

4. FINANCIAL RESPONSIBILITY HEARING:
DESERT STAR CONSTRUCTION, LICENSE NO. 77677

Licensee was not present.

Hearing Officer Leggett continued this matter to the November 4, 2015 hearing.

5. FINANCIAL RESPONSIBILITY HEARING-CONTINUED FROM AUGUST 5, 2015:
WILLIAM MARLO BECK DBA, A + LOCK AND GLASS, LICENSE NO. 78838

Licensee was present.

Hearing Officer Leggett approved the financial review with a \$10,000 bond by October 15, 2015 with a six (6) month financial review.

6. FINANCIAL RESPONSIBILITY HEARING:
DONALD DAVID HYATT DBA, HYATT TILE & STONE, LICENSE NO. 37377

Licensee was present.

Hearing Officer Leggett approved the reactivation of the license with a \$10,000 monetary license limit and \$10,000 bond with a six (6) month financial review.

7. FINANCIAL RESPONSIBILITY HEARING:
CONCRETE IMAGES INC, LICENSE NO. 78899

Licensee was present.

Hearing Officer Leggett approved the financial review, lowered the license limit to \$10,000 with a \$10,000 bond and a six (6) month financial review. If Respondent provides a financial statement supporting the license limit during the financial review, staff is authorized to approve the financial review.


There being no further business to come before the Board, the meeting was adjourned by Hearing Officer Leggett at 9:00a.m.
