1. RECONSIDERATION HEARING:

WILMAC CONSTRUCTION, License No. 23939

Licensee was present and represented by Michael McCauliffe, Esq. at the hearing.

Hearing Officer Leggett ordered the revocation of license number 23939 be stayed for six months. To assure compliance with ordered restitution, it is further ordered that Respondent's license number 23939 shall be revoked, with the imposition of the revocation being stayed for six months. If the ordered restitution is made, the revocation shall not take effect and the license will be voluntarily surrendered. Upon compliance with the ordered restitution, the imposed revocation shall be lifted. Provide written proof satisfactory to the Board's Executive Officer of having paid restitution to all injured parties. Said restitution shall be paid within six months. If Respondent fails to make the ordered restitution within the said period, then immediately upon expiration of the stay, the license shall be revoked. This order shall be self-operative with respect to the disciplinary action ordered.
