## **BOARD DISCIPLINES CONTRACTORS AT JANUARY HEARINGS**

**RENO and HENDERSON, Nev.** – The Nevada State Contractors Board took action against several licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its January hearings in Reno and Henderson.

---

**Buckeye Drywall & Paint, LLC**, license number 77247 (painting and decorating), based out of Las Vegas, Nev., was found in violation for committing a fraudulent or deceitful act, diversion of funds, and failure to establish financial responsibility. Licensee was fined \$5,000 and assessed investigative costs. Licensee was ordered to make restitution of \$65,000 and to provide the Board with a current financial statement that supports the license limit. The license was placed on probation for five years.

**Carl Agbleze, owner, dba C. A. Builders**, license number 67913 (carpentry), based out of Las Vegas, Nev., was found in violation for failure to provide notice of intent to file a lien, contracting beyond the scope of the license, failure to include the Residential Recovery Fund information on a contract or proposal, and failure to establish financial responsibility. Licensee was fined \$850 and assessed investigative costs. The license will remain suspended until the Board receives a current financial statement that supports the license limit.

**Morrison Construction**, license number 47260A (carpentry and repairs), based out of Las Vegas, Nev., was found in violation for contracting beyond the scope of the license, aiding or abetting an unlicensed person, committing a fraudulent or deceitful act, failure to include the license number or monetary limit on a bid or contract, failure to include the Residential Recovery Fund information on a contract or proposal, and failure to establish financial responsibility. Licensee was fined \$2,650 and assessed investigative costs. The license limit was reduced to \$10,000.

**Yan Hong Liu, dba C & L Enterprise**, license number 60690 (residential and small commercial), based out of Las Vegas, Nev., were found in violation for construction or repairing a mobile home without an appropriate license. Licensee was fined \$500 and assessed investigative costs.

---

**Rod Koprek Roofing**, license number 50820 (roofing and siding), based out of Las Vegas, Nev., was found in violation for failure to include the license number or monetary limit on a contract or proposal. Licensee was fined \$100. An additional Cause of Action on this case was postponed to be heard until February 17, 2016.

---

**Calvada Concrete, LLC**, license number 78388 (concrete contracting), based out of Henderson, Nev., was found in violation for failure to establish financial responsibility, failure to comply with a Board request for information or records, and failure to comply with an order of the Board. The license was revoked. Licensee was fined \$4,500 and assessed investigative costs.

**The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine of up to \$10,000 per offense, order corrective action, suspension, revocation or other action.**
