TWO CONTRACTOR LICENSES REVOKED DURING SEPTEMBER DISCLIPINARY HEARINGS

RENO and HENDERSON, Nev. – The Nevada State Contractors Board took disciplinary action against licensed contractors for violations of Nevada Revised Statutes Chapter 624 during its September hearings. To comply with social distancing and related emergency directives, all Board hearings are conducted online via Zoom, in compliance with Open Meeting Law requirements.

License revoked.

License revoked.
Penguin Construction, LLC	70384 (B General Building)	Found in violation of: NRS 624.3013(3) Failure to establish financial responsibility. Fined \$500 and assessed investigative costs.
Renovations of Las Vegas, Inc.	72107 (B-2 Residential & Small Commercial; B-6 Commercial Remodeling)	Found in violation of: NRS 624.302(5) Failure or refusal to respond to request to cooperate in investigation of complaint. Fined \$250 and assessed investigative costs.
DLR Inc. A Nevada Corporation, dba All State Roofing	63019 (C-15A Roofing)	Found in violation of: NRS 624.302(6) Failure or refusal to respond to request for records. Fined \$250 and assessed investigative costs.
Passick Pools, LLC	81276 (A-10 Commercial & Residential Pools)	Stipulated to violating: NRS 624.3013(5) pursuant to NAC 624.700(3)(a) Failure to comply with a notice to correct NRS 624.3016(5) Failure to comply with regulations concerning residential pools and spas NRS 624.302(6) Failure or refusal to comply with a request for information or records. Fined \$1300 and assessed investigative costs.

The Nevada State Contractors Board is committed to protecting the public's health, safety, and welfare through licensing and regulation of the construction industry. Under Nevada Revised Statutes, a licensee is subject to disciplinary action by the Board for failure to comply with the requirements of the laws or regulations governing contractors. Violations may result in Board action against the contractor's license. The State Contractors Board has the power to regulate contractors and discipline licensees who violate NRS 624. Disciplinary action may consist of a fine, order corrective action, suspension, revocation or other action.

NRS 624.212(7) allows an unlicensed individual who was issued a cease and desist order to petition the Board in writing to lift or alter the order within 15 days after receiving the cease and desist order. Upon receipt of this request, the Board will schedule an administrative hearing to review the facts and make a determination on the validity of the cease and desist order and assess any fines or costs that may be associated with the investigation.
